In accordance with the Protocols for Implementing and Reviewing Charges Established by the Attachment J Rate Formulas of the Versant Power Open Access Transmission Tariff for Maine Public District ("MPD OATT"), Versant Power hereby submits an informational filing setting forth its transmission real power loss factor that is to take effect June 1, 2023, as well as workpapers supporting the calculation of this loss factor.¹

1. Request for Privileged Treatment

Versant Power respectfully requests privileged treatment, in accordance with 18 C.F.R. § 388.112, for the detailed transmission, load, and generation information contained in the file <Real Power Loss Calculations 2022 CUI-PRIV>. Versant Power considers such information to be "commercial . . . information obtained from a person [that is] privileged or confidential." Accordingly, good cause exists for the Commission to grant this request for privileged treatment of this information.

All matters concerning this request for privileged treatment should be directed to the undersigned. In accordance 18 C.F.R. § 388.112(b)(2)(i), Versant Power states that the Protective Agreement filed in Docket No. ER15-1429-000 on May 1, 2019, can be used for purposes of the present request.
